

T&C Affiliate

This Agreement is entered into between Quick Funded Ltd (the "Company") and the acknowledging party (the "Affiliate"), collectively referred to as the "Parties" or individually as a "Party."

- 1. **Definitions** 1.1. The following definitions apply to this Agreement:
 - Business Day: Any calendar day other than Saturday, Sunday, or a Federal holiday in the United Kingdom.
 - Affiliate Account: The Affiliate's account with the Company for the Services.
 - Affiliate Content: All text, data, software, images, audio, or video material provided by the Affiliate or the Company for using, developing, or maintaining the Services.
 - Compensation Plan: The fees or commissions payable to the Affiliate, as outlined in Appendix I.
 - Effective Date: The date of this Agreement when the Affiliate registered on the Company's website.
 - End User: Any person or entity authorized by the Affiliate to use the Services.
 - End-User Account: An account with the Company held by an End User to access the Services.
 - End-User Content: Text, data, images, or other information provided by End Users in relation to the Services.
 - Error: A perceived error.
 - Fees: The fees as determined by the Fee Schedule in Appendix I.
 - Intellectual Property Rights: Patents, copyrights, trademarks, and other intellectual property rights.
 - Mark Guidelines: Guidelines for using the Company's marks.
 - Marks: Trademarks, logos, URLs, and other identifying symbols.
 - Services: The services as described in this Agreement.
 - Software: Online software applications and tools provided by the Company.
 - Virus: Anything that may adversely affect computer software, hardware, or networks.
- 1.2. **Affiliate Reference** A reference to an Affiliate includes any corporation or other body corporate, wherever and however incorporated or established.
- 1.3. **Construction** Words in the singular include the plural, and vice versa.
- 1.4. **Statutory Reference** References to statutes or statutory provisions are as in force at the date of this Agreement.

- 1.5. **Subordinate Legislation** References to statutes include subordinate legislation made at the date of this Agreement.
- 1.6. Articles & Sections References to articles and sections are to this Agreement.
- 1.7. **Priority** This Agreement prevails in case of inconsistencies with other documents.
 - 2. Representations and Warranties 2.1. The Affiliate represents and warrants:
 - The Affiliate is duly organized, validly existing, and authorized to conduct business.
 - The Affiliate has the legal authority to execute and deliver this Agreement.
 - There is no litigation involving the validity of this Agreement.
 - The Affiliate operates as an independent contractor and not as an agent or employee of the Company.
 - No person acting on behalf of the Affiliate is entitled to claim brokerage or finder's fees.
 - The Affiliate is in compliance with applicable laws and regulations.
 - 3. **Termination** Termination conditions include insolvency, litigation, non-compliance with laws, and the Company's discretion.
 - 4. **Indemnification** The Affiliate agrees to indemnify and hold Quick Funded Ltd harmless from any claims, losses, or damages arising from the Affiliate's actions, including breaches of the agreement and violations of laws.
 - 5. **Fraudulent Traffic** Quick Funded Ltd reserves the right to delay payments to the Affiliate if suspicious activity is detected in the Affiliate's account. Quick Funded Ltd can also withhold fees if fraudulent traffic is determined. Additionally, Quick Funded Ltd can render tracking URLs inoperative if it suspects fraudulent activity.
 - 6. **Force Majeure** Both parties are not liable for breaches of the agreement due to events beyond their control, such as natural disasters or pandemics.
 - 7. **Provision of Information / Data Protection** The Affiliate is required to provide certain information to Quick Funded Ltd and consents to the collection and use of their personal information in accordance with applicable data protection laws.
 - 8. **Cookies** The use of cookies on Quick Funded Ltd's website is mentioned, and users are given the option to manage cookie settings in their web browsers.
 - 9. **Confidentiality** This agreement includes provisions regarding the handling of confidential information, including the return of materials and technology provided by Quick Funded Ltd.
 - 10. **Notices and Communication** The agreement specifies the methods of communication between the parties and how notices will be sent.
 - 11. **Miscellaneous** This section covers various other aspects of the agreement, including marketing restrictions, the governing law and jurisdiction, the entire agreement clause, severability, and more.
 - 12. **Appendix I Compensation Plan** This section details the compensation plan for the affiliate, including the percentage of fees they will receive based on the number of End Users they refer.
